Recent changes to disability procedures

Beginning in December, 2011 the Social Security Administration (SSA) announced a new policy of keeping the name of the Administrative Law Judge for a Disability hearing anonymous until the day of the hearing. This has come as a shock to the legal community and is considered very controversial.

There are many people speculating about the reasons for this change. Some believe that it is to prevent attorneys and judges from favoritism, some believe it is to [evaluate judges](#) to ensure they use a standardized method of determining fair rulings, some believe the SSA is trying to cut expenses for the states. (If the judge is not assigned to the case until the day of the hearing, this may encourage both judges and attorneys to perform hearings via video.) Regardless of the reasons for this change in SSD procedures, the impact has been huge to legal staffs across the country. Hearings may take longer or be more complicated as a result, because knowledge of the judge beforehand allowed legal teams to be efficient in tailoring and streamlining their preparation to each judge's specific likes and dislikes. Our Disability department has taken a head-on approach and is well prepared to meet this new challenge.

The lawyers, case managers, and entire staff in our Disability department are always well prepared, even without knowing which judge will handle which cases. Led by the firm's attorneys, case managers Valeria Coll and David MacWilliams double check the details of every case, making sure all the "i's" are dotted and the "t's" are crossed. Since each judge has different preferences and expectations for hearings, David says that the team is taking an aggressive approach to catering toward the most intricate and involved judicial expectations. "We know what different judges might ask for, so we are being incredibly detail-oriented in having all materials ready for judicial review before they even ask," he says. "One thing that can make this process the most efficient possible," says Val, "is to have all evidence in well before the hearing date, and provide the client's medical provider with a simplified form that the attorney can then take to the hearing." This form helps to define the nature of the medical condition on a single piece of paper, rather than making the court take extra time to read through the entire medical file for pertinent information.

Florida probate for out-of-state property owners



Many people from around the world visit Florida on vacation to relax and enjoy all that the Sunshine State has to offer. It is not uncommon for those visitors to love the experience so much that they invest in timeshare or vacation property here in order to have a reliable and comfortable place to return as often as they want. But out-of-state property owners should be aware of the probate procedures and special provisions if they plan to leave this property to their loved ones when they pass away.

When an out-of-state property owner passes away, their Will needs to include a provision for ancillary probate administration. State statute [734.102](#) describes the particulars of ancillary administration in detail, but generally, if a non-resident of the state dies leaving property in Florida, the property cannot be distributed directly to the beneficiaries named in the Will. Because there will have to be cases opened in two county probate courts (the deceased person's home county as well as the county where the property is located) the deceased person's Will must name someone with the power to administer in a Florida probate court. If no one is named to administer the disbursement of the property to the beneficiaries, it can take a great deal longer for the property to work its way through probate court, and the beneficiaries of the property may have to go through some unforeseen hassle and difficulties with the Florida county probate court.

Car accidents with out-of-state drivers vacationing in Florida

Because Florida is such an ideal vacation destination for visitors from around the world, the tourist industry here is one of the most active in the entire country. There are many considerations to take into account when living in an area with high tourist traffic, including knowing what to do [if you're involved in a car accident](#) with an out-of-state (or foreign) visitor, or if your family or friends who are visiting from out of state experience an accident.

Florida is a "no-fault" auto insurance state, which is why Floridians are required to carry at least \$10,000 in personal injury protection (PIP) on their insurance policies. However, other states do not require PIP coverage for their drivers, and insurance and injury claims can quickly become tangled. Whether you file a claim with your insurance company or with the other person's changes the location of the laws followed, because it changes whether you are filing a claim for tort (negligence) damages or an insurance contract claim.

If you are in an accident with a foreign visitor who has rented a car, it is especially important that you realize that rental companies are not liable for the damage caused by the drivers of their cars. It can be extremely difficult or impossible to serve someone in another country with a lawsuit, so in this case it would be very wise to speak with an attorney about the options of your insurance policy that will help you recover from any property damage or injuries of the accident.
