

Alarmingly, the number of veterans who are returning home from overseas conflicts suffering from traumatic brain injuries is increasing at a faster rate than ever before. These individuals may have severe life-long-lasting effects that could impair them and impact their ability to live life fully. Because of the physical and mental ailments that can result, veterans suffering from traumatic brain injuries may be eligible for veterans' disability benefits and Social Security disability benefits. Veterans can also suffer from the after-effects of prescription medication they were taking when overseas after they return home. These medications can contribute to delayed recovery and re-entrance into civilian life, as well as may be linked to a higher rate of veteran suicide and self-inflicted injury. This disturbing information is something else we have discussed in a recent blog because we feel it is important to shine light on these situations occurring in our communities.

This Memorial Day we'd like to encourage you to take an active stance in your community and remember that the veterans who return home are lucky in some respects, but still suffering. Show them that you recognize their great sacrifice and the ultimate sacrifice of those who have not returned home at all. Memorial Day is a day every year to remind each and every one of us of the cost of freedom.

Concussions and traumatic brain injuries in the NFL

On May 3, 2012 more than 100 former NFL players filed suit against the NFL in federal court in Atlanta. This is just the most recent case in a slew of lawsuits by former players against the NFL. The plaintiffs in all these cases claim that the NFL insufficiently dealt with the concussion epidemic that has only recently been highlighted by advocates and the national media. They assert counts of fraudulent concealment, negligent misrepresentation, conspiracy to defraud, loss of consortium and more. Adding to the drama surrounding the legal standoff is the tragic death of former pro-bowler Junior Seau.



Chronic Traumatic Encephalopathy (CTE) - also known as "punch drunk symptom" - is associated with memory loss, confusion, impaired judgment, impulse control problems, aggression, depression, and, eventually, progressive dementia, and is the result of serious, violent, and continued head traumas. Concussions are the ultimate silent killer; they are very difficult to diagnose and the incentives to avoid confronting the problem are great. The NFL culture of sweeping concussions under the rug further complicates the already difficult task of identifying concussions during a game. Minor concussions can carry minimal symptoms but multiple small concussions over a career can have devastating effects, as exposed by the Seau tragedy. Properly diagnosing concussions and ensuring player safety is now the challenge confronting the NFL.

occur in car accidents, at work, or from an accident. And what about the person who suffered multiple concussions but does not have the explicit and easily recognizable symptoms associated with CTE? What if they have just suffered a general slowdown in mental capabilities that is often associated with multiple concussions?

A worker's compensation or disability claim is much more difficult to establish in this case, as a disability may not become evident for months or years after the injury. This problem is true for any person who has suffered multiple or even, a single, damaging concussion while on the job. An experienced worker's compensation lawyer is needed to prove that your disabilities were caused by your on-the-job head injury and worker's compensation is not only appropriate, but necessary. The current situation in the NFL reminds us all how even if our jobs aren't glamorous they can affect us for our entire lives.


Your legal rights and the damaging side effects of prescription medications: SSRI's, Yaz, and Actos

Millions of people are prescribed medication every year for various physical and psychology maladies. Selective Serotonin Reuptake Inhibitors (SSRI's): Celexa, Lexapro, Prozac, Sarafem, Paxil, Pexeva, Zoloft SSRI's are a class of drugs that affect many chemicals in the brain that pass messages between nerve cells. They are commonly prescribed for adults for the

disorders such as post-traumatic stress disorder (PTSD) in adults. Recent research has found that serious birth defects can results from pregnant women who take this type of drug during the course of their pregnancy. These problems can include heart defects, lung defects, cranial defects (including deft lip or palate), pulmonary hypertension, leg or arm defects, extreme behavior disorders, spina bifida, and more. These medical conditions can require surgery, medication, and life-long treatment. Although there are some warnings given about the effects of these medications, people are often not sufficiently told about the serious results that can occurr. Despite their popular usage, some brands have allegedly been linked to the development of serious side effects such as heart and cardiovascular problems, high blood pressure, pulmonary embolism, deep vein thrombosis, blood dots, stroke, gall bladder issues, and death. Other potential side-effects have been reported, and some people suffer from a combination of many.
